



"Mentoring: The Why and How of Raising Future Leaders" (Q & A)

Ben Burmaster, Founder & CEO, Snuggle Bugz, Toronto, ON - A born entrepreneur, Ben founded five successful companies before pursuing his passion project with his wife, Tanya. Ben and Tanya started Snuggle Bugz in 2006, based on their shared vision of instilling confidence in Canadian parents navigating the early stages of parenthood.

With an extensive Enterprise Resource Planning (ERP) development background from previous software businesses he'd founded, Ben established Snuggle Bugz early on as a

true omnichannel retailer, competing equally on- and off-line against big box stores, major online marketplaces, and boutique retailers alike.

Driven by his family's strong sense of community and desire to give back, Ben spearheads Snuggle Bugz's philanthropic initiative, <u>KindNest</u>. This sustainable "trade not aid" program provides under-employed Haitian artisans with training and work opportunities that help them raise themselves and their families out of poverty, while developing a line of baby goods that are sold in-stores with a portion of proceeds donated.

Early is his entrepreneurial days, Ben benefited from the investment of seasoned entrepreneurs in his development. The mentoring he received early on provided a sounding board for his wild ideas on innovation, coached him to grow his leadership capabilities, and ultimately helped him to clarify his strategic vision. This experience was so instrumental in Ben's growth, he has made it a priority to invest in the new wave of entrepreneurs in his community, offering the same guidance and support to help other leaders build confidence in themselves.




Shant Mardirosian

"Beyond The Burger's Priest: My Entrepreneurial & Life Journey" (Q & A)

Shant Mardirosian, Founder, The Burger's Priest, Toronto, ON - Shant received a Bachelor of Religious Studies from Tyndale University College. Israel was called a "kingdom of priests" and that became an inspiration for the name of his restaurants. He built up The Burger's Priest chain to 14 locations and then sold to Cara Foods. He is now working on his next big idea. His recipe for entrepreneurial success: authenticity, hard work, self-awareness.

"In the beginning, Shant Mardirosian the founder of the Burger's Priest wanted to be a pastor. Burgers weren't part of the plan. Mardirosian became a Christian when he was 19. He studied at Tyndale University College in Toronto, earnestly praying and struggling to discover his life's purpose. Eventually, he dropped his dreams of ministry and came to terms with his entrepreneurial instinct. It took some time to scrape together enough money for his first location, a tiny hole on Toronto's Queen Street opened in June 2010. Eager devotees would walk an extra mile then line up down the block to order juicy offerings off a repurposed hymn board. God had something to do with it as well, he says. To the uninitiated, "priest" might seem like a mockery of high church ceremony. But the restaurant name is actually Protestant in inspiration, based on the idea that anyone, anywhere can bring the sacred into the mundane. The Burger's Priest slaps full bible narratives on the wall in ancient languages. Faith might be integral to the Founder's identity and brand, but there maintains a separation of church and plate as The Burger's Priest knows business was built on shaping beef, not believers." - **Brent Wittmeier, Edmonton Journal published on March 11, 2015**

Ray Pennings


"Private Business, Public Faith"

Ray Pennings, Co-founder, Cardus, Ottawa, ON - Ray Pennings, co-founded Cardus (**www.cardus.ca**) in 2000 and currently serves as Executive Vice President. Cardus exists as an independent think tank located in Hamilton, ON. Initially founded as the "Work Research Foundation," Cardus emerged from a desire to translate the richness of the Christian faith tradition into the public square for the common good. Part of the focus of Cardus relates to "Work + Economics."

Ray completed a degree in History at McMaster University and obtained a Master of Arts in Religion degree from Puritan Theological Seminary. He has led a number of large research

projects at Cardus over the years and was lead author on *Death is Natural: Reframing the End-of-Life Conversation in Canada*. In addition to authoring Cardus reports and columns he has also written chapters in several publications including *Church and Caesar* (RHB, 2004), *Living for God's Glory* (RHB, 2011), *Calvin the Revolutionary* (RHB, 2010), *Religious Liberty and the Law* (Routledge, 2017), and *The Handbook of School Choice* (Wiley-Blackwell, 2017).

Ray's grasp of applied public theology is evident not only through his writings, but through his volunteer efforts as well. He was the founding president of **EduDeo** (formerly Worldwide Christian Schools) and has served as Chair on the board of Redeemer University College, and as a board member for the Civitas Society and the Rosebud School for the Arts. Paul Henderson to Receive Entrepreneurial Leaders Award



Paul Henderson, Canadian hockey legend, Toronto, ON – Paul began his hockey career in Lucknow, Ontario. After winning the Memorial Cup in 1962 with the Hamilton Red Wings, he moved to the NHL. Paul played 18 years of professional hockey with the Detroit Red Wings, Toronto Maple Leafs and Atlanta Flames.

Paul is best known for his pivotal role in the 1972 Canada-USSR Series when Canada needed a victory in each of the last three games to win the series. Amazingly, Paul scored the winning goal in each of the three games. His winning goal in the last game is regarded as one of the greatest sports moments in the last century, and Team Canada '72 was voted the Team of the Century by the Hockey Hall of Fame.

Paul has been honoured by Canada's Sports Hall of Fame on two occasions: he was first inducted as an individual in 1995, and again ten years later along with his 1972 teammates. The Summit Series team has also been honoured with a star on Canada's Walk of Fame. Henderson has been inducted into the Ontario Sports Hall of Fame (1997), the International Ice Hockey Federation Hall of Fame (2013) and has been honoured by Hockey Canada with the Order of Hockey in Canada as part of its 2013 class. He was named a Member of the Order of Canada in December 2012 in recognition of "his engagement in support of a range of social and charitable causes" along with his achievements on the ice. In 2014, he was named to the Order of Ontario.

Paul has not only succeeded on the ice but also in the lives of literally thousands of individuals. Paul currently serves with LeaderImpact where he has been developing people for leadership since 1984. His full-time ministry involvement has lasted twice as long as his professional hockey career. He refers to himself as an exhorter and an encourager. He wants to encourage people to go deep and finish strong. He has been an inspiration for many marketplace leaders.

Richard served as a senior pastor at Friendship Baptist Church in Winnipeg, and then as the


president of the Canadian Southern Baptist Seminary in Cochrane, Alberta Canada for 13 years. He continues to serve as the seminary's Chancellor.
