

Do you teach your children about your faith?	58%	42%


HOW WOULD YOU DESCRIBE YOURSELF WHEN IT **COMES TO THE WHOLE AREA OF PERSONAL FAITH?***








REFUGEES IN CANADA WHO REPORTED USING FOOD BANKS












WORLDWIDE POPULATION GROWTH







RELIGIOUS POPULATIONS IN CANADA




